



# **Education Programs**

Colorado River Alliance provides immersive, hands-on STEM education that is TEKS aligned to elementary and middle school aged students throughout the river basin.

The Alliance's flagship programs have returned to in-person programming and educators are thrilled. Fields trips, whether to the Wilkerson Center for Colorado River Education or to the Mobile River, create lasting memories.

Water quality and quantity are top issues facing our state, nation, and globe. Every elementary and middle school student in Texas receives water science education - the Alliances brings that curricula to life to ensure this essential learning is fun, engaging, and memorable.

Each school year, the Alliance staff connects directly with educators and principals who serve Title 1 schools to provide first priority registration. For two weeks prior to opening registration to the public, the CRA team reserves all spots for schools considered Title 1 schools.

### **Engagement Projects**

To cultivate appreciation and an understanding of our community's dependence on the Colorado River, the Alliance provides engaging opportunities and firsthand experiences with the River. People who pick-up microtrash at Travis County East Metro Park, dive for tires at the bottom of Lake Travis, or take the Water Pledge also gain the invaluable realization of the source of their drinking water.




On behalf of the members of the Board of Directors, the Endowment Board, the Advisory Council, and the staff of Colorado River Alliance, thank you for your support of our programs.
