

THE RIVER & CHALLENGE AHEAD



The Colorado River basin has always experienced floods and droughts. Due to numerous factors, both extremes are becoming more frequent, more severe, and more costly. These conditions can be catastrophic for the region's economy, agriculture, wildlife, and neighborhoods along the river. These extreme weather conditions have contributed a significant threat to water quantity for all communities in the River basin. Dramatic changes in weather along with the significantly increasing population in the River's basin and resulting water consumption are a leading concern for the communities which rely on the Texas Colorado River.

THE VITALITY OF OUR WORK

The Colorado River Alliance endeavors to serve communities throughout the full length of the Colorado River Basin, to support, activate, or create efforts to conserve and protect the River. Colorado River Alliance has three decades of experience providing education, activation, resources, and collaboration through its work.

With a commitment to innovation and collaboration, the Alliance provides educational and engagement activities that provide Texans with knowledge and tools to protect the Texas Colorado River and ensure its long-term vitality. The organization is headquartered in Austin, Texas at the site of Tom Miller Dam and its flag-ship programming is currently centered in Central Texas. Alongside those efforts, initiatives are taking place in the Highland Lakes area, Bastrop, Columbus, and near the Gulf of Mexico at Matagorda Bay.

Founded in 1994 with support from LCRA, the Alliance is a standalone 501(c)3 successfully leading programs that reach 14,000 community members and school children annually. The Colorado River Alliance continues to partner with LCRA and many others to provide river stewardship education and to be a champion for the people, ecosystems, communities, and businesses that depend on this essential natural resource. The Alliance has a long history engaging young people, as well as adults, through practices of teaching and working together to protect water quality and conserve water quantity. The Alliance is in a unique position to extend its highly successful education services as well as its experience in inspiring a generation of river stewards. Educating students, kindergarten through college-age, to protect and conserve our region's water is central to its mission. The Colorado River Alliance is a highly visible, resilient organization that maintains long-standing partnerships with hundreds of partners throughout the basin. The Alliance benefits from an expert and engaged staff as well as an active Board of Directors, Advisory Council, Legacy Leaders, Tributary League, and a young professionals' group, The River Society. The Alliance also has an Endowment which supports its education and outreach programs. 
